Death benefit guaranteed to remain level.



Premiums guaranteed to remain level.



Passes on to the beneficiary of choice.



Avoids probate/court.



Death benefit is paid out tax-free.



Doubles for accidental death.

Immediately Effective (if approved for coverage).
